PIPES KEYNOTES AHI POLICY FORUM ON TURKISH POLICY

AHI hosted the policy forum "The Evolution of Turkey's Policy in the Eastern Mediterranean: Implications for U.S. Interests" featuring Keynote Speaker Daniel Pipes, president, Middle East Forum and Taube Fellow at the Hoover Institution of Stanford University; and a panel of experts who examined the topic on February 6, 2012 at the Capital Hilton, Washington, DC.

In his keynote speech, Pipes demonstrated how Turkey's ruling AKP government has evolved over three elections to become a truly bellicose party since its initial election to power

FOREIGN AFFAIRS CHAIRMAN ATTENDS SCREENING OF CYPRUS DOCUMENTARY

U.S. Rep. Ileana Ros-Lehtinen (R-FL), chairman, House Committee on Foreign Affairs, was the guest speaker at an AHI "Town Hall Screening" of the one-hour documentary "Cyprus Still Divided: A U.S. Foreign Policy Failure" held February 10, 2012, at the Archimedean Academy Amphitheater, Miami, Fla.

In remarks, Chairman Ros-Lehtinen described the "overwhelming military force" used by Turkey in the invasion of Cyprus by citing a BBC interview of Antonis Antoniou, who was five years old at the time, and she spoke of the unfortunate consequences of the invasion that resulted in thousands of

in 2002. He added that it will be “difficult to credit future elections,” hinting that Turkey’s 2011 election may be its last democratic one. Pipes believes Prime Minister Recep Tayyip Erdogan is attempting to undo the Ataturk revolution taking Turkey from a secular nation to Shari’a Law; from “small Turkey” to neo-empire; and away from Europe.

Domestically, Pipes cited the following concerns: the growing anti-American sentiment in Turkish public opinion, the Gulen Movement’s penetration of law enforcement, the government’s favoritism toward a network of Islamic companies, the privileges extended toward Islamic media and the large volume of jailed journalists, and the jailing of top military personnel under the Ergenekon conspiracy. On foreign policy, Pipes recounted how he was impressed by Turkey’s lack of interest in the Middle East and its European direction when he visited in 1992. Now, Pipes points to Turkey’s “zero problems” foreign policy as leading to an increased focus on the Middle East, an intense meddling into Iraqi affairs, hostility toward Israel, ambitions to control Syria, a reversal on Libya, and support for Hamas. The result is Prime Minister Erdogan has become the “Hero of the Arab Street,” according to Pipes. He cited additional emerging threats toward Cyprus and Israel over oil and gas exploration in the eastern Mediterranean, a boycott of the EU during the Republic of Cyprus’ Presidency of the European Union Council, Kastelorizo should Greece expand its economic exclusive zone (EEZ), and telling Turks not to integrate into German society.

Pipes identified several security concerns with respect to United States interests which began March 1, 2003 when Turkey’s parliament turned down the United States’ request to open a northern front against Iraq. He described this act as a “jolt” to the relationship. Additional security concerns Pipes cited include Turkey’s joint military exercises with China and cooperation with Brazil to sideline UN sanctions on Iran’s nuclear program. However, he did identify areas of cooperation with United States interests that include Syria and the position of a radar system focused on Iran.

Pipes concluded that although Iran is the greatest immediate threat to the Middle East, Turkey presents the most dangerous long-term threat because unlike Iran the AKP government is legitimately elected to power and is working through demo-

cratic means. He also opined that Turkey’s NATO membership should be either suspended or terminated based upon its actions with China, opposition to Libya, and the pressure it has applied on the NATO establishment to place Turkish officials in key positions.

The panel of experts discussing the topic featured: Dr. Harry Dinella, former U.S. Army Foreign Area Officer for Greece and AHI Fellow; Professor Van Coufoudakis, rector emeritus, University of Nicosia, Cyprus and former president, Modern Greek Studies Association and AHIF Fellow; Doug Bandow, senior fellow, Cato Institute; and Dr. Raphael Danziger, senior research advisor, Policy & Government Affairs, AIPAC and editor-in-chief emeritus, *Near East Report*. James Jatras, principal, Squire Sanders Public Advocacy and former senior foreign policy advisor, Republican leadership of the U.S. Senate, moderated the panel.

Greek-Cypriots killed; sixteen hundred reported missing; and over two hundred thousand forcibly expelled from their homes and driven into exile. The congresswoman also cited the religious and cultural destruction that has occurred under Turkish occupation and the violations of religious freedom, including the interruption of Christmas Day liturgy in 2010.

“That is why it is important that films such as you will see tonight remind us of the continued presence of foreign forces on the island and the violence and division that has resulted,” Congresswoman Ros-Lehtinen said, who understands the suffering of refugees because she is also one from Cuba. “So I know from my own experience what is at stake if we in this country fail to support the Greek-Cypriots in their struggle.”

Moreover, the congresswoman emphasized her repeated efforts to press for the withdrawal of Turkish forces from Cyprus in communications with the Obama administration and meetings with Turkish officials, including most recently Turkish Foreign Minister Ahmet Davutoglu. “...I am determined to continue to press him and every Turkish official I meet with until they understand that the U.S. will not abandon Cyprus and will continue to make it an issue in U.S.-Turkish relations until there is a just settlement,” Congresswoman Ros-Lehtinen said.

A discussion about the documentary and the Cyprus issue featuring AHI President Larigakis followed the screening and the congresswoman’s remarks. Aleco Haralambides, Esq., founding member and vice president, Archimedean Academy, and AHI board member, moderated. The event was held in cooperation with The Archimedean Schools and Dolphin Capital Partners.

Church, Va., January 18, 2012. A discussion about the documentary and the Cyprus issue featuring AHI President Nick Larigakis and AHI Board of Directors Secretary Nicholas G. Karambelas, Esq., followed. Attorney Arthur Dimopoulos, publisher, *Odyssey*, moderated the panel discussion, and St. Katherine's Parish Council President Jim Stoucker offered opening remarks. Olympia Neocleous, deputy chief of mission, Embassy of the Republic of Cyprus, was also present. The event was held in cooperation with the Col. Peter N. Derzis AHEPA Chapter 438, Arlington, Va.

The documentary was also screened on both coasts of the United States. On March 31, 2012, the Hermes Expo International, at the Trump Taj Mahal, Atlantic City, N.J. served as the venue for a screening. A discussion about the documentary and the Cyprus issue featuring AHI President Larigakis and Ambassador Achilleas Antoniadis followed. The event was held in cooperation with the Hermes Expo and the Hermes Young Professional Initiative. AHI is grateful to the organizers of the Hermes Expo, including its Founder Paul Kotrotsios and Ms. Aphrodite Kotrotsios, director, Hermes Young Professional Initiative, for helping to organize the screening, which proved to be a success.

In April, the "Town Hall Screenings" came to San Diego, April 17 and Seattle, April 19. In San Diego, it was held at the University of California, San Diego Faculty Club in cooperation with the Hellenic Cultural Society of San Diego and North San Diego County AHEPA Chapter 505. Dr. Thomas Gallant, Nicholas Family Endowed Chair, professor of Modern Greek History, UC, San Diego, moderated the discussion. In Seattle, the event was held at St. Demetrios Greek Orthodox Church in cooperation with AHEPA Chapter 177, The Hellenes of the Northwest, Greek-American Historical Museum of Washington State, and Daughters of Penelope Alcides Chapter 160. Dr. Nektaria Klapaki, University of Washington Hellenic Studies Program, moderated.

The documentary concluded 2011 with a screening held December 14 in Norfolk, VA. AHEPA Chapter 122 House was the venue. It was held in cooperation with the Cyprus Benevolent Society of Tidewater, Va., and AHEPA Robert E. Lee Chapter 122, Norfolk. Dr. Christopher Nicholas helped to organize the screening and moderated the panel discussion that followed.

Thus far, the documentary has been screened in 18 cities throughout North America.

AHI PRESIDENT RECEIVES NATIONAL AHEPA HONOR

AHI President Nick Larigakis received a national honor from the American Hellenic Educational Progressive Association (AHEPA) before an audience of 200 prominent Greek American and community leaders on Capitol Hill, March 28, 2012. President Larigakis received the inaugural AHEPA Outstanding Public Advocacy Award at AHEPA's "Salute to Civic Responsibility" Dinner.

The AHEPA Outstanding Public Advocacy Award, which was presented by AHEPA Executive Director Basil Mossaidis, recognizes individuals who demonstrate unbridled passion in the

course of advocating for a public policy issue or cause. AHEPA cited Larigakis' steadfast advocacy on Capitol Hill, in the grassroots, and in the op-ed pages of influential publications as the basis for his honor.

In acceptance, AHI President Larigakis spoke about the importance of defending our proud Hellenic culture and the influence his parents had upon instilling these values in him as a teenager. He said, "I take exceptional honor and humility to receive an award tonight with such distinguished honorees... There is special meaning for me to receive this award tonight, the first of its kind, from AHEPA and to receive it on Capitol Hill because when the American Hellenic Institute was founded in 1974, its number one priority was that invasion of Cyprus.

"With AHEPA's money we were able to put into place an embargo against the Republic of Turkey for its illegal invasion of Cyprus against extraordinary odds at the time. It is not something anyone of us should take lightly—that victory."

Larigakis called on the Greek American community to rededicate itself to the issues and challenged the community to start resolving them, moving past the introduction of congressional resolutions. He also thanked the AHI staff for the support it provides to him as AHI president.

Also honored along with President Larigakis were: U.S. Congressmen John Sarbanes (D-MD) and Ed Royce (R-CA), both of whom received the AHEPA Pericles Award; and Cyprus Federation of America President Panicos Papanicolaou, who received the inaugural AHEPA Excellence in Leadership Award.

AHI SUBMITS TESTIMONY TO HOUSE APPROPRIATIONS SUBCOMMITTEE

AHI submitted testimony to the House of Representatives Appropriations Subcommittee on State, Foreign Operations, and Related Programs on the Obama Administration's foreign aid proposals for FY2013 on April 24, 2012.

In the best interests of the United States, AHI's testimony opposed:

1. any military assistance the administration will request for Turkey until Turkey removes its troops and illegal Turkish settlers in Cyprus;
2. aid the administration will request for the Former Yugoslav Republic of Macedonia (FYROM); and
3. any reduction that might be introduced in the aid levels for the UN Peacekeeping Force in Cyprus.

In addition, the testimony strongly opposed the continued reduction of Economic Support Fund (ESF) funding for Cyprus. The FY2013 proposed level of funding is \$3.2 million. However, AHI testified that it supports continued ESF funding for Cyprus as long as it is tied exclusively to bi-communal projects of the island as mandated by U.S. law. The law states U.S. funds are to support only "measures aimed at reunification."

"It is vital to ensure the Greek American community's positions on American foreign aid to this region are submitted for the public record via the Subcommittee's acceptance of written testimony," said President Nick Larigakis, who submitted the testimony. "We thank the Subcommittee for the opportunity to submit our testimony which is presented with the best interest of the United States in mind."

AHI BOOK EVENT COMMEMORATES TRUMAN DOCTRINE, MARSHALL PLAN

AHI, in cooperation with the Embassy of Greece, hosted a book presentation and reception in commemoration of the Truman Doctrine and the Marshall Plan, March 6, 2012, on Capitol Hill. Ms. Photini Tomai, director, Service of Diplomatic & Historical Archives, Hellenic Ministry of Foreign Affairs, made a presentation about the book, “Documentary History of Greece: 1943-1951, Truman Doctrine and Marshall Plan” of which she was the editor. The event was supported by U.S. Reps. Gus Bilirakis (R-FL) and Carolyn Maloney (D-NY), co-chairs, Congressional Caucus on Hellenic Issues and sponsored by the Onassis Foundation.

Tomai’s book utilizes more than 180 documents to detail the implications of the Truman Doctrine and the Marshall Plan to Greece. In her presentation, Tomai identified as being quite clear the impetus by scholars and archivists for undertaking the documentary project, which was to properly commemorate the Marshall Plan—a “generous program” that contributed “decisively to the triumphant reemergence” of Europe after World War II.

Although Tomai made it quite clear she was not making a plea for a similar economic aid package for Greece today, she did convey that the lessons of the Marshall Plan must not be lost and that America has everything to gain from teaching those lessons today. “We are grateful for the support your government has signaled for the Eurozone and Greece as a member of that union,” she said.

Ambassador Vassilis Kaskarelis, ambassador of the Hellenic Republic to the United States, and U.S. Rep. Ileana Ros-Lehtinen, chairman, House Foreign Affairs Committee, provided remarks. Other members of Congress in attendance were: U.S. Reps. Gus Bilirakis, Frank Pallone (D-NJ), Chris Van Hollen (D-MD), Linda Sanchez (D-CA), and Sheila Jackson Lee (D-TX).

AHI HONORED AT PHILADELPHIA GREEK INDEPENDENCE PARADE

AHI was honored at the 2012 Philadelphia Greek Independence Day Parade presented by the Federation of Hellenic-American Societies of Philadelphia and the Greater Delaware Valley. It was the first time an institution has received such an honor by the Federation. The parade was held Sunday, March 18, 2012.

AHI Foundation President Dr. Spiros Spireas served as the parade’s Grand Marshal, which is the highest honor afforded by the Federation. It was bestowed to Dr. Spireas in appreciation of his many works as a prominent businessperson and efforts on behalf of the Greek American community, Metropolis, and his unwavering support of Hellenic issues. AHI Founder Eugene Rossides and AHI President Larigakis were also unanimously selected Honorary Marshals. AHI CELEBRATES GREEK INDEPENDENCE DAY AT THE WHITE HOUSE

AHI celebrated Greek Independence Day at the White House on March 22, 2012. AHI President Nick Larigakis attended the ceremony officiated by President Barack Obama, Vice President Joe Biden and His Eminence Archbishop Demetrios. "We thank President Obama for demonstrating 'philotimo' toward the Greek American community by hosting this event to honor Greek Independence," Larigakis said. "The event served to reaffirm the strong bonds of friendship between Greece and the United States and to bring attention to the fact that this relationship is etched intrinsically by virtue of the noble democratic ideals and principles that guided our Founding Fathers in establishing our own country."

AHI PRESIDENT ATTENDS WHITE HOUSE BRIEFING

Prior to the celebration of Greek Independence Day at the White House on March 22, AHI President Larigakis attended a White House briefing on U.S.-Greece relations with Administration officials to discuss important topics of concern including: an economic update, Greek-American community engagement efforts, and the White House Business Council.

President Larigakis shared his views on how U.S.-Greece relations can be strengthened, including ways to assist with Greece's economic crisis. For example, he suggested the United States can send a positive message by having the U.S. commerce secretary lead a delegation of American business leaders to Greece. He noted that there has not been any significant American investment in Greece for more than thirty years. Larigakis also commented on the foreign policy challenges impacting Greece and the eastern Mediterranean region, which are core policy issues for the Greek American community that require proper resolutions. He cited NATO ally Turkey's continued occupation of the Republic of Cyprus, which is an EU nation; and the importance of securing religious freedom for the Ecumenical Patriarchate.

"The Greek American community would like to see the Administration, in fact all Administrations, be properly engaged with it on foreign policy discussions as they pertain to U.S.-Greece and U.S.-Cyprus relations," Larigakis said.

The Washington Post article "Washington can be a frontline for international combatants" by Emily Wax (January 11, 2012) featured a quote from President Nick Larigakis. In the article, Larigakis affirmed proximity to the U.S. government as an explanation to the importance of Washington to the lobbying efforts of ethnic and international advocacy groups.

"Our arsenal is not weapons," said Nick Larigakis, president of the American Hellenic Institute, which promotes U.S. relations with Greece and Cyprus and is often at odds with Turkey's

goals. "It's having a voice in Washington where we can use the rule of law to provide credibility to our arguments."

A video piece compiled by *Chicago Tribune* Columnist John Kass titled "On America and Greece, lessons to be learned" posted April 4, 2012, featured an interview with AHI President Nick Larigakis. Kass reports on Greece's economy, its effect on the Greek people, and ponders if it is a foreshadowing of what is to come to America. In his interview, Larigakis affirms Greece's resiliency based upon it being the standard-bearer of democratic ideals and the cradle of Western Civilization. "What is happening in Greece today pales by comparison in terms of what has transpired within the glorious history of this country for over 2,500 years," Larigakis said. Letters to the Editor

The *Washington Times* published a letter to the editor on Wednesday, February 15, 2012 written by President Larigakis. "Macedonia is Hellenic Name" was submitted in response to the February 7, 2012 article "Macedonia complains Greece is 'irrational,'" by Ben Birnbaum. In the article, FYROM's Foreign Minister Nikola Poposki "complains" Greece is being "irrational" on the name recognition issue and that Greece's position is "unreasonable." Larigakis defended Greece by asserting FYROM is acting irrationally with its leadership thinking it can "usurp 2,500 years of Hellenic history and culture." He cited examples of provocative actions taken by FYROM against Greece, including renaming its airport and naming its national highway after Alexander the Great. "FYROM's provocations are irrational because they do not display good neighborly relations required of a NATO member," wrote Larigakis. In closing, Larigakis contended FYROM need only blame her own irrational position for not being in NATO and not Greece, which "has already compromised on the issue."

AHI joined with Armenian American and Kurdish American organizations asking Congress to call upon the Obama administration to investigate the use of U.S. arms in a December 28, 2011 Turkish airstrike that killed 35 Kurdish boys and young men along the Turkey-Iraq border. In a letter dated January 10, 2012, the organizations requested an investigation and public report to Congress to see whether Turkey violated U.S. arms export laws by using American-supplied weaponry in the airstrike. The American Kurdish Information Network, Armenian National Committee of America, Kurdish Human Rights Watch, and Kurdish National Congress of North America were also signatories to the letter, which was addressed to the bipartisan leaderships of the congressional committee’s overseeing the State Department and Pentagon.

AHI Welcomes Berman’s Letter to Secretary Clinton on Cyprus

AHI welcomed a March 22, 2012 letter by U.S. Rep. Howard Berman (D-CA), ranking member, House Committee on Foreign Affairs, sent to U.S. Secretary of State Hillary Clinton that draws attention to two Cyprus-related developments perpetrated by Turkey and calls for a reassessment of the United States’ Cyprus policy. The two developments cited by Rep. Berman are Turkey’s threatened military action in response to Cyprus’ hydrocarbon exploration in its exclusive economic zone (EEZ) and Turkey’s ongoing efforts to alter the demographic composition of Cyprus.

“The reunification of the Republic of Cyprus is of critical importance to the stability of the Eastern Mediterranean, a vital U.S. interest,” wrote Rep. Berman. “That’s why I am deeply disturbed by two Cyprus-related developments...These developments directly undermine long-standing elements of the U.S. position in support of Cyprus reunification and call into ques-

tion our ability to sustain that position.”

“We welcome Ranking Member Berman’s letter which aims to bring these two concerns to Secretary of State Clinton’s attention and calls for a reassessment of the United States’ Cyprus policy,” said President Nick Larigakis. “Through its Policy Statements, the American Hellenic Institute has long called on the U.S. government to undertake a specific set of actions to resolve the Cyprus issue in a manner that upholds the rule of law, which includes respect for international law.”

AHI, AHEPA Express Disappointment to Airline on Athens Route Cancellation

AHI and the American Hellenic Educational Progressive Association (AHEPA) sent a joint letter to United Continental Holdings Inc.’s President and Chief Executive Officer Jeffery A. Smisek to express disappointment with United Continental’s November 2011 decision to terminate the seasonal non-stop flight from Newark (EWR) to Athens, Greece, which was a Continental route. AHI President Nick Larigakis and AHEPA Executive Director Basil Mossaidis strongly recommended United Continental to rethink the decision, and as an alternative, add a seasonal summer route from Washington/Dulles to Athens thus connecting two of the world’s greatest capital cities. In addition, Larigakis and Mossaidis requested a meeting with Mr. Smisek to discuss the issue in greater depth.

AHI Welcomes Line of Questioning about Turkey in GOP South Carolina Debate

AHI welcomed the line of questioning on whether Turkey belongs in NATO as raised by *Fox News* Anchor Bret Baier during the *Fox News/Wall Street Journal* Republican Debate in Myrtle Beach, S.C. on January 16, 2012.

During the debate, Baier raised the following question to Republican Presidential Candidate *Governor Rick Perry*: “*Governor Perry, since the Islamist-oriented party took over in Turkey, the murder rate of women has increased 1,400 percent there. Press freedom has declined to the level of Russia. The prime minister of Turkey has embraced Hamas and Turkey has threatened military force against both Israel and Cyprus. Given Turkey’s turn, do you believe Turkey still belongs in NATO?*”

“This is a welcomed discussion especially at the presidential debate level,” said AHI President Nick Larigakis.

AHI Welcomes Commentary Warning of Turkish Aggression in Mediterranean

AHI welcomed a commentary titled “Kastelorizo: Mediterranean Flashpoint?” by Daniel Pipes, president, Middle East Forum and Taube Fellow at the Hoover Institution of Stanford University, which was published in *The Washington Times* on Feb. 9, 2012. Pipes writes: “*Turkey’s prime minister, Recep Tayyip Erdogan, and his ruling AKP party colleagues accept Greek control of Kastelorizo and its six nautical miles of territorial waters, but not more and certainly not its full EEZ rights. Indeed, in their eyes, Greek assertion of an EEZ constitutes a*

casus belli. By neutering Kastelorizo, Ankara can lay claim to a large economic area in the Mediterranean and block cooperation among its adversaries. This is why the island could become a flashpoint.” Pipes correctly cites increased Turkish belligerence and aggressiveness toward Cyprus, Israel, Iraq, and Syria since the AKP government took full control of the Turkish army in July.

AHI Welcomes European Parliament’s Written Declaration on Famagusta

AHI welcomed a written declaration issued by the European Parliament calling on the government of Turkey to act according to UN Security Council Resolutions and previous European Parliament Legislative Committee reports and return the Famagusta sealed-off section to its lawful inhabitants.

The written declaration begins with “whereas the city of Famagusta in the Republic of Cyprus was captured by the invading Turkish forces in August 1974,” which is language strongly supported by AHI. “Oftentimes, the word ‘invasion’ tends to get dropped from the lexicon of those who discuss the Cyprus issue,” said President Larigakis. “We cannot forget we are talking about an invasion and occupation of a current member of the European Union in the Republic of Cyprus.” It also contains language noting UN Security Council resolutions 550 (1984) and 789 (1992), which speak to the transfer of this area to the United Nations and the 1979 High Level Agreement between the Greek Cypriot and the Turkish Cypriot communities, which stated that priority should be given to the resettlement of Famagusta under the UN auspices. The declaration also “calls on the Government of Turkey to act according to the aforementioned UNSC Resolutions and Report Recommendations and return the Famagusta sealed-off section to its lawful inhabitants, who must resettle under conditions of security and peace” urging the EU institutions to coordinate their efforts with Parliament to promote Turkey’s cooperation.

The European Parliament intends to send the declaration to the European Commission, the European Council, the governments of the European Union’s member-states, the UN Secretary General and the government of Turkey. In all, 390 members of the European Parliament signed it on February 2, 2012.

AHI Commends Designating Turkey a “Country of Particular Concern”

On April 11, 2012 AHI commended the United States Commission on International Religious Freedom (USCIRF) on the release of its 2012 Annual Report which designates Turkey a “Country of Particular Concern” (CPC). By designating Turkey a CPC, the USCIRF is recommending Secretary of State Hillary Clinton designate it a CPC as well.

“We applaud the Commission for correctly identifying Turkey as a ‘country of particular concern,’ meaning the Turkish government has engaged in, or has tolerated, particularly severe violations of religious freedom,” said President Larigakis. “Also by designating Turkey as a CPC, the Commission reaffirms

the Turkish government’s continued tolerance of assaults upon its many minority populations including the Greek Orthodox Christian minority and the Ecumenical Patriarchate. These are all actions that violate the founding principles and laws of the United States.”

The Commission’s report specifically cites Turkey’s policies that: deny non-Muslim communities the right to train clergy, including the closure of the Greek Orthodox Halki Patriarchal School of Theology; officially do not accord the ecclesiastical title “ecumenical” to the Ecumenical Patriarch; interfere in the internal governance of the Greek Orthodox community; and retain the power to expropriate religious minority properties.
